INFORMATION: Human CD56 is an adhesion molecule from the Ig superfamily which is restricted to NK cells in the immune system. It is believed that NK cells form a first line of defense against tumor cells and cells infected with bacteria and viruses. 
STORAGE CONDITIONS: Store at 2 - 5^oC. Freeze/Thawing is not recommended.

BUFFER: 50 mM Sodium Phosphate pH 7.5, 100 mM Potassium Chloride, 150mM NaCl, 0.5 mg/ml Gentamicin Sulfate (as a preservative).

PRODUCTION: Antibody was Protein A purified from (low FBS containing) tissue culture supernatant. Purity was >95% Immunoglobulin by SDS-PAGE with less than 1% Bovine Immunoglobulin. Binding of anti-CD56 mAb +GAM/FITC

PERFORMANCE: Five x 10^5 ficoll prepared human peripheral blood mononuclear cells were washed and pre incubated 5 minutes with 20 µl of 250 µg/ml human IgG (to block non specific binding) after which they were incubated 45 minutes on ice with 80 µl of anti-CD56 antibody at **10 µg/ml**. Cells were washed twice and incubated with 2^o reagent Goat anti-Mouse IgG/FITC (Catalog #232-011), after which they were washed three times, fixed and analyzed by FACS. A net **8.7%** sub population of the cells stained positive with a mean shift of **0.69** log₁₀ fluorescent units when compared to a Mouse IgG1 negative control (Catalog #278-010).
