
BUFFER: 50 mM Sodium Phosphate pH 7.5, 500 mM Potassium Chloride, 150mM NaCl, 15% Glycerol, 0.2% BSA, 0.04% NaN₃ (as a preservative).

PRODUCTION: Protein A purified antibody from tissue culture supernatant was conjugated to R-Phycoerythrin through a sulfo-ester linkage. Unconjugated antibody was removed using size exclusion chromatography. Antibody conjugate is at **0.5 mg/ml** with an A_{565}/A_{280} ratio of 2.96.

PERFORMANCE: Human **Raji** cells were incubated 45 minutes on ice with 80 μ l of anti-CD95/R-PE at a dilution factor of **1:50** (10 μ g/ml). Cells were washed three times, fixed and analyzed by FACS. Cells stained positive with a mean shift of **2.01** \log_{10} fluorescent units when compared to a Mouse IgG1/R-PE negative control (Catalog #278-050) at a similar concentration. Binding was blocked when cells were pre incubated 10 minutes with 20 μ l of 0.5 mg/ml anti-CD95 antibody (Catalog #316-020).
